Separate application in prescribed form has to be filed by the Trust before the respective Commissioner of Income tax, who is having jurisdiction, in order to seek benefit u/s. 80G of the IT Act, 1961.

Further, this certificate cannot be used as a basis for claiming non deduction of tax at source in respect of investments etc., relating to the Trust. Separate application in the prescribed forms has to be filed before the Assessing Officer in order to claim non deduction of tax at source.
